**A RESOLUTION OF THE COMMISSIONERS OF THE TOWN OF KEYSTONE  
HOME RULE CHARTER COMMISSION APPROVING  
THE PROPOSED CHARTER AND SUBMITTING THE  
PROPOSED HOME RULE CHARTER TO THE ELECTION COMMISSION**

**WHEREAS**, on March 28, 2023, an election was held on the question of incorporation of the Town of Keystone, Colorado, formation of a Home Rule Charter Commission, and election of nine members to serve on the Home Rule Charter Commission; and

**WHEREAS**, the Charter Commission has drafted a Home Rule Charter for the Town of Keystone pursuant the authorization of Article XX of the Constitution of the State of Colorado and the process set forth in the Municipal Home Rule Act of 1971, Part 2, Article 2, of Title 31, in the Colorado Revised Statutes; and

**WHEREAS**, within one hundred eighty (180) days of its election, the Charter Commission shall submit to the Election Commission a proposed charter; and

**WHEREAS**, pursuant to C.R.S. § 31-2-206(9), two public hearings on the Home Rule Charter were held on May 22, 2023, and June 21, 2023, after proper public notice; and

**WHEREAS**, the Charter Commission has held fourteen (14) meetings for the purpose of drafting and considering the language of the proposed draft charter; and

**WHEREAS**, in addition to the public hearings, the Charter Commission received and considered significant communication from the Keystone Community related to the drafting of the charter and the Charter Commission interviewed elected officials and Town Managers from other similar home rule municipalities; and

**WHEREAS**, the Charter Commission approves a proposed charter for submission to the Election Commission and for the Election Commission's referral to the Registered Electors of the Town of Keystone.
